Mayor Stephen Macaulay called the monthly meeting to order at 6:00 P.M.

Present: Mayor Stephen Macaulay, Trustee Joan Postorino, Trustee Larry Brown, Trustee Robert Pauly, DPW Supervisor/Fire Chief Ralph Skinner II, and Clerk/Treasurer Renee Kolb. Guest: none. Absent: Trustee Shane Wisner and Zoning Enforcement Officer Derek Weaver.

A motion to accept the May 5, 2025 minutes was made by Trustee Joan Postorino and seconded by Trustee Larry Brown. All in favor.

A motion made by Trustee Robert Pauly and seconded by Trustee Larry Brown to hire Dennis O'Brien as the Village part-time police officer starting June 3, 2025 for \$30.00/hour for no more than 15 hours/week per the 2025-2026 budget. All in favor.

Mayor Stephen Macaulay handed out the Amended June 2025 appointments adding Police Officer Dennis O'Brien.

Zoning Permit 2025-3 for Nathaniel Kincheloe, 509 Church St. for a six-foot-high fence was passed with a motion from Trustee Larry Brown and seconded by Trustee Joan Postorino.

Fire Chief Ralph Skinner reported the following:

1. New fire engine prebuilt meeting will be June 9, 2025 at 9:00 AM.
2. Watertown Fire Department is submitting for a grant for knox boxes and are asking if surrounding fire departments would like to be named on the grant application. Glen Park has opted in. Knox boxes are for businesses so the fire departments can access the locked building.

DPW Supervisor Ralph Skinner reported the following:

1. We have received the new Bobcat skid steer.
2. Trustee Joan Postorino motioned and Trustee Larry Brown seconded to sell the 2016 Bobcat skid steer at Auctions International. All in favor.
3. DPW summer laborer Nahjeed Abel will be starting June 17.
4. Summer projects will be sidewalks and Evolis sign installation.
5. Submitted DPW monthly report. Attached.

Motion by Trustee Joan Postorino and seconded by Trustee Robert Pauly to authorize Clerk/Treasurer Renee Kolb to collect the Utilities Warrant dated June 1, 2025 as follows:
